

Notification – Shared Path Works

Shared path construction is scheduled to begin the week of March 31, 2025. This include a new shared path along Forrest Street and Mitchell Street - making it safer and easier for pedestrians, cyclists, and the whole community to get around.

- What to Expect:
- Works are expected to take approximately 10 weeks (weather and contractor permitting)
- ✓ Old pathway and tree removal where necessary
- ✓ Traffic management or redirection may be in place for public safety
- Temporary driveway access restrictions may apply

Ordinary Meetings of Council are held on the fourth Wednesday of each month, (excluding January and December, in which the meeting is held on the third Wednesday due to the Christmas period). Meetings commence at 6pm in the Shire's Council Chambers located at the Administration Office.

Council receive reports and recommendations, covering a range of topics crucial to the development and governance of the Shire. Following are a summary items recently deliberated by Council:

2024/2025 Midyear Budget Review:

Financial Management Regulations require local governments to conduct an annual budget review. The review is presented to Council for consideration and adoption. The results of the review are then submitted to Department of Local Government, Sport and Cultural Industries (DLGSC). This process maintains the Shire's financial prudency and progression.

Shire of Cunderdin Compliance Audit Return 2024

Annual Compliance Audit Returns (CAR) is part of the Shires regulatory obligations. Completion of the CAR ensures accountability of the Shire to the community. Building good governance strengthens our capacity to meet community needs and aspirations. The CAR showed that the Shire has demonstrated transparency in all aspects of Local Government compliance processes.

Consideration of Superannuation Contributions for Council Members

Amendments to the *Local Government Act 1995*, proposes that Shires offer superannuation payments to Councillors. This provision, will give greater recognition to the dedication and time invested by Councillors. It is hoped this will encourage diversity in local government representation, aligning with broader workforce standards. Council resolved to support this provision so long as individual Councillors can be given a choice to receive or opt out of receiving the contributions.

Council Policy Manual – Advisory and Working Groups Policy & Stakeholder Working Group Membership – Play our Way Project & Better Regions Round 2 Project

It was resolved that an Advisory and Working Group Policy be added to the Shire's Council Policy Manual, subsequently Stakeholder Working Groups will be formed for delivery of the Cunderdin Memorial Aquatic and Wellness Hub & WeatherShield Courts Projects. This will ensure projects are community-driven, inclusive, and align with Shire long-term development goals; enhancing public trust, satisfaction, and overal project success.

Receival of the Local Emergency Management Committee Minutes

Local government's have Local Emergency Management Committees (LEMCs) for their districts. The Shire of Cunderdin LEMC met on 12 March discussing operational requirements of the Shire's emergency management teams.

Proposal for Membership: Joining the Wheatbelt East Regional Organisation of Councils (WEROC)

Council considered and resolved to join a Regional Organisation of Councils (ROC). Collaboration with WEROC will provide numerous resource sharing opportinities for our Shire.

Road Naming – Industrial Lot Development

Council approved that the portion of road at the east end of Centenary Place be named Industrial Way.

Other Considerations and Updates

Lease proposal for a lot of land in Meckering was considered.

Tenders received for the supply of the new Community Bus were presented, discussed and awarded.

Updated that construction of the Shire dwelling on Yilgarn Street has commenced.

Councillors advised the two new Shire dwellings will be delivered to the Mitchell Street site in April 2025.

Progression report given that the Cunderdin Bowling Green replacement is underway.

After discussions with effected sporting groups Council were advided the new Cricket Nets location has been selected.

Council were informed that grant funding has been awarded to the Shire for Airfield drainage works and safety upgrades.

The meeting was advised that Active Transport Funding secured by the Shire will enable construction of paths to link key desinations within the Shire.
