Background

Melanie Grage is a student at Cunderdin District High School who has played football with the Cunderdin Junior Football Club. She has previously represented the Cunderdin Junior Football Club at the Watheroo Cup and East Avon Association.

Comment

School Sports WA have an U15 Girls Interstate Australian Football Team competing in the 2023 Championship, which will be held in Ballart from the $22^{nd} - 29^{th}$ July 2023. Melanie has been offered and accepted a position on this team.

Acceptance into a state team is an outstanding achievement for Melanie as a player and merit is also due to the Cunderdin Football Club who have assisted her development as a player.

As mentioned in Melanies cover letter, accepting a position in the state team comes with considerable costs. While she is willing to undertake her own fundraising to finance this opportunity Melanie is reaching out to the Shire of Cunderdin for financial support.

The Shire of Cunderdin Council Policy Manual has provision for assisting individuals a maximum grant of \$200 for interstate travel to represent Western Australia in an interstate championship. While many of the eligibility criteria are satisfied in Melanie's application for assistance there is one criteria that is not met being that Melanie is not a resident of the Shire of Cunderdin as her residential address is in the Shire of Quairading.

- a) The maximum grant that may be awarded in this category is \$200 for interstate travel and \$300 for international travel.
- b) The eligibility criteria for assessing financial support applications (Individual Development) for people who have been selected to represent the State or Nation in interstate or international championships, competitions or significant cultural, academic or community service programs are:
 - only residents of the Shire of Cunderdin are eligible to apply.
 - applicants must be selected to represent Western Australia or Australia in the area of sport, arts, cultural or educational activities.

- applications must be supported either by the relevant governing body of sport or the state/federal/voluntary organisation supporting the activity.
- there must be a demonstrated selection process which entitles the applicant to represent the state or national body or activity.

- funds will only be provided towards travel or accommodation expenses.
- priority will be given to applicants who have demonstrated initiative and endeavour in raising funds for themselves.

To provide an update on the matters the Chief Executive Officer has been addressing over the past month.

Background

Local Roads and Community Infrastructure Program Phase 3 Projects

O'Connor Park

O'Connor Park is still scheduled to be completed for the grand opening on the 30 June 2023.

Meckering Earthquake Memorial Garden

The contractor has been appointed and the initial project planning has commenced. Works are expected to commence in July 2023.

Cunderdin Golf Club - Shed

The Golf Club has been advised of the funding and the Golf Club has purchased the materials. The Club has commenced construction.

Gliding Club - Ablutions

The Gliding Club is obtaining quotes to complete the works. Once this is completed the Shire will meet with the Club to discuss the works and project management options.

Meckering Apex Park

The Meckering Action Group decided not to proceed with the redevelopment of the APEX park, opting to wait for the stage 3 redevelopment of Meckering concept plan. With the LRCI funding allocated to the project (\$20 000), we are planning to fence the front access of the playground and if budget allows provide a shade structure over the picnic area.

Tennis Club - Installation of the Soft Fall.

Completed.

Cunderdin Sport and Recreation Club - Blinds

Completed.

Additional Road Funding

The Shire will also receive an additional \$211,400 to be used on rural roads before 30 June 2025.

Cunderdin Industrial Lot Development

Development WA have completed the final plans for the industrial development and prepared a Contract of Sale. Council is waiting for CBH to advise if they have any further conditions on the sale of the land.

Council is responsible for the conveyancing and settlement costs and this should be completed in the near future. It is expected that contracts for the utility works will be let before the end of the financial year.

There has been a small amount of asbestos found on site that will need to be cleaned up. The majority of this is in the nature reserve between the industrial lots and the residential area.

Development WA are appointing a landscaper to complete the plantings in the nature reserve to screen the industrial lots from the residential area.

Watts Street Land Lease

Council received one expression of interest for the lease of the Watts Street land. The offer has been accepted.

Local Government Reform

The first tranche of reforms to the Local Government Act 1995 has passed through Parliament. These local government reforms, the most significant in 25 years, are designed to strengthen local democracy and provide for greater transparency, efficiency and accountability.

This first tranche focuses on electoral reform and has been introduced first to ensure the changes will be in effect for the October 2023 ordinary elections. The second tranche of reforms is due to be introduced later in 2023.

A key feature of the State Government's reform agenda is standardising:

- the number of council members
- the method of electing the mayor or shire president and
- the use of wards.

Early Payment of Federal Assistance Grants (FAGs)

The recently handed down Federal Budget maintained the Commonwealth's commitment to supporting Local Government through the provision of Financial Assistance (FA) Grants however, for the first time in many years, this year's budget did not include a bring forward FA Grant payment.

This will not have any effect on the Shire of Cunderdin's financial position or cash flow for 2022-23 or 2023-24.

National Trust Meeting

The CEO and Deputy CEO met with Ms Kelly Rippingale of the National Trust to discuss the Old Pump House Building.

The discussion was extremely informative and has will provide the Shire some direction in going forward. A more detailed update will be given at the meeting.

- (b) forward a copy of that report to the Minister, by the end of the next financial year, or 6 months after the last report prepared under section 7.9 is received by the local government, whichever is the latest in time.
