#### **Summary**

#### **Background**

Under the Government of Western Australia, *Freedom of Information Act (FOI Act) 1992* Section 96(1) requires each government agency, including local governments, to prepare and publish annually an Information Statement. The Shire of Cunderdin Freedom of Information Statement has been developed in accordance with the *FOI Act 1992* Section 94 that details the requirements of an information statement, in relation to an agency.

Currently our Freedom of Information Statement is due to be reviewed and published to keep in line with the *Freedom of Information Act (FOI Act) 1992* Section 96(1).

#### That Council:

- 2. Publish the Information Statement as per the requirements of Freedom of Information Act 1992.

#### Comment

Freedom of Information gives the public a right to access government documents, subject to some limitations. In Western Australia, under the *FOI Act 1992*, the right applies to documents held by most State government agencies (such as departments, public hospitals, public universities and State government authorities), Ministers and local government. Together, these bodies are referred to as "agencies".

Documents accessible under the *FOI Act 1992* include paper records, plans and drawings, photographs, tape recordings, films, videotapes or information stored in a computerised form. Agencies are required to assist applicants to obtain access to documents at the lowest reasonable cost. Anyone can also apply to have personal information about themselves in government documents amended if that information is inaccurate, incomplete, and out of date or misleading.

The Information Commissioner is an independent officer who reports directly to Parliament. The position is established by the *FOI Act* and is supported by staff of the Office of the Information Commissioner.

Part 5 Publication of information about agencies

96. Information statement, each agency to publish annually

- (1) An agency (other than a Minister or an exempt agency) has to cause an up to date information statement about the agency to be published in a manner approved by the Minister administering this Act -
  - (a) within 12 months after the commencement of this Act; and
  - (b) at subsequent intervals of not more than 12 months.

A reference in this Act to an information statement, in relation to an agency, is a reference to a statement that contains -

- (a) a statement of the structure and functions of the agency;
- (b) a description of the ways in which the functions (including, in particular, the decision making functions) of the agency affect members of the public;
- (c) a description of any arrangements that exist to enable members of the public to participate in the formulation of the agency's policy and the performance of the agency's functions;
- (d) a description of the kinds of documents that are usually held by the agency including
- (i) which kinds of documents can be inspected at the agency under a written law other than this Act (whether or not inspection is subject to a fee or charge); and
- (ii) which kinds of documents can be purchased; and
- (iii) which kinds of documents can be obtained free of charge;
- (e) a description of the agency's arrangements for giving members of the public access to documents mentioned in paragraph (d)(i), (ii) or (iii) including details of library facilities of the agency that are available for use by members of the public;
  - (f) a description of the agency's procedures for giving members of the public access to the documents of the agency under Part 2 including
    - (i) the designation of the officer or officers to whom initial inquiries as to access to documents can be made; and
    - (ii) the address or addresses at which access applications can be lodged;
- (g) a description of the agency's procedures for amending personal information in the documents of the agency under Part 3 including
  - (i) the designation of the officer or officers to whom initial inquiries as to amendment of personal information can be made; and
  - (ii) the address or addresses at which applications for amendment of personal information can be lodged.

To provide an update on the matters the Chief Executive Officer has been addressing over the past month.

#### **Background**

Local Roads and Community Infrastructure Program Projects

Phase 3

#### O'Connor Park

Contractor has been appointed and work has commenced on the project. The project is expected to be completed in March 2023.

## Meckering Earthquake Memorial Garden

The Request for Quote for the works is nearly completed which includes the planning and design of the design of the project. The Requests for Quotes have been called for and an on site meeting with the prospective contractors is planned for mid November 2022.

#### Cunderdin Golf Club – Shed

The Golf Club has been advised of the funding and has commenced planning.

## Gliding Club - Ablutions

The Gliding Club is obtaining quotes to complete the works. Once this is completed the Shire will meet with the Club to discuss the works and project management options.

## Meckering Apex Park

The Meckering Action Group decided not to proceed with the redevelopment of the APEX park, opting to wait for the stage 3 redevelopment of Meckering concept plan. With the LRCI funding allocated to the project (\$20 000), we are planning to fence the front access of the playground and if budget allows provide a shade structure over the picnic area.

Tennis Club – Installation of the Soft Fall. Completed

Cunderdin Sport and Recreation Club - Blinds Completed.

## Community Emergency Services Manager (CESM)

A new CESM has been appointed and will commence on the 21st November 2022.

The Shires of Quairading and Tammin have advised that they do not have accommodation for the proposed candidate. The Shire of Cunderdin has a private lease expiring in December 2022 and has advised the tenants that their lease will not be renewed and the new CESM will move into that dwelling.

This will result in the CESM spending more time in Cunderdin and may result in a rejuvenation of the existing DFES services.

## **Cunderdin Industrial Lot Development**

The Heritage and Cultural Survey has been conducted on the proposed site. This has comprised of a site dig and an ethnological site visit. The planner has also completed design work for the entrance of the CBH facility.

#### Cemetery Update

The Department of Education has requested that the Shire provide a more evidence based assessment that the land currently owned by the Education Department to the west of the existing cemetery is required for the cemeteries expansion.

The Shire has been required to engage a suitably qualified engineer to assess the land to the east of the existing cemetery and advised why it is not suitable for expansion.

This work has been completed and the report will be forwarded to the Department of Education.

#### **Local Government Election Transition Arrangements**

The Shire of Cunderdin has commenced preparing the documents for the Community Consultation stage of the representation review. These reports will be circulated throughout the Shire by all means of communication.

#### <u>Signage</u>

New signage for the Shire has been designed with the assistance of Castledine and Castledine. The designs were reviewed by Council at the Forum on the 10 November 2022.

It was agreed that quotes would be sought for "banner style" signs on the Great Eastern Hwy and new signs at the Shire boundaries on the major (bitumen) roads.

New signs have also been sought for the office, depot, transfer station and pool. Road finger signs will be replaced with the new logo signage.

Town information sign and tourism sign will be replaced subject to individual project development and cost.

Quotes have been sought for new sign based on the designs agreed upon.

#### New Dwellings – 30 Mitchell Street

A tender document has been developed to construct two, three bedroom, two bathroom transportable dwellings at 30 Mitchell Street. It is intended to go to tender as soon as possible.

## Cunderdin and Pingelly Primary Health Centre Review

The President Deputy President and CEO met with Rachele Ferrari (WACHS) and Karen Horsley (WACHS) to discuss the Cunderdin Primary Health Centre Review (the Review). It was advised by WACHS that the Review has not been approved by the WACHS CEO and is still in draft form.

The Shire advised WACHS that the Shire's preferred option was to have a new palliative care room added onto the existing building. Ms Ferrari advised she will convey the Shires request and report back to our next meeting in late November 2022. The shire also suggested several other factual changes to the document. These changes were taken on board by WACHS.

## **Ian Roberts Lodge**

The Shire has sought expressions of Interest for the lease of Ian Roberts Lodge. There where multiple phone inquiries and several emails expressing interest in the premises.

Written submissions meeting the criteria of the advertised Expression of Interest were received by two (2) interested parties. Please see Attachment 9.5.1 - 1st Expression of Interest and Attachment 9.5.2 - 2nd Expression of Interest for further information on the applicants intended use of the property.

Councils preferred option is to lease the premises to a commercial operator in order to maximise the potential of the building. Staff are in continued discussions with interested parties and there will be an update given at the meeting.
