

#### **Proposal/Summary**

For the newly elected Councillors to take the Declaration by Elected Member in accordance with the provisions of the Local Government Act 1995.

### **Background**

Provisions within the *Local Government Act 1995*, S2.29, and the Local Government (Constitution) Regulations 1998, C13, state that a person elected as a councillor has to make a declaration in the prescribed form before acting in the office and the format in which that declaration is to be made.

Four positions on Council were open for nomination in the Shire of Cunderdin 2023 Ordinary Elections. Three (3) of these positions were for a four (4) year term in office from 2023 – 2027 and one (1) position was for a two (2) year term in office, 2023 – 2025.

All four (4) positions were filled by nominating candidates and they are to be duly elected unopposed.

As per the Local Government (Elections) Regulations 1997 Part 12C, the Returning Officer conducted the drawing of lots establishing which candidates would be elected for the four (4) year and two (2) year terms.
